#### How we secure, store and retain your data

Blessing in Disguise secures the personal information you provide on cloud computer servers in a controlled, secure environment, protected from unauthorised access, use or disclosure. Personal information is protected through the use of encryption such as the Secure Socket Layer (SSL) protocol, when transmitted.
